Griswold Community Schools Chemical Application Requirements

- 1. Bids are to be stated in dollars per application for each particular area, listed below. Square footage is not available. The contractor is responsible for visiting the sites and doing any measurements they feel necessary.
- 2. All fertilizer includes slow-release nitrogen and potassium. At least one treatment will include phosphorous. Additional broadleaf herbicide will be sprayed as needed to help control late emerging weeds. Please check with the district maintenance assistant (Kevin Farr 712-778-2154) for starting and ending dates. If you have questions about whether a particular area needs to be treated, please check with the district maintenance supervisor.
- 3. Vendors will need to include a copy of the appropriate licenses.
- 4. The Board reserves the right to reject any and all bids.
- 5. The Board reserves the right to waive technicalities in the best interest of the district.

ELEMENTARY/MIDDLE SCHOOL/HIGH SCHOOL:

- a) Fertilizer with crabgrass preventative in early spring.
- b) Broadleaf weed control, including fence lines, in the summer.
- c) Spot broadleaf control though the season.

ATHLETIC FIELDS:

- Weed control of football practice field, infield areas/dirt areas of softball and baseball fields.
- a) Early Spring:
 - Multiple Core Aeration plus dragging to smooth field
 - Fertilizer with crabgrass preventative
- b) Late spring
 - Broadleaf weed control, including fence lines
 - Fertilizer with crabgrass preventative
- c) Summer
 - Fertilizer with grub control (fence to fence)
 - Spot broadleaf weed control, including fence lines
- d) Late Summer
 - Fertilizer with extra slow-release nitrogen
 - Spot spray for crabgrass and broadleaf weed control, including fence lines.
- e) Fall
 - Fertilizer for fall treatment
